



## **Fairbite Food Club Queen Edith's - Donations**

St James' Church runs a Fairbite Food Club in collaboration with Cambridge City Foodbank (a registered charity). Our Fairbite Food Club is open each Saturday morning 10.30am - 12noon.

Fairbite Food Clubs provide affordable food for those who need it. Members pay a small membership fee when they shop (£3 for a small shop and £5 for a large shop) and choose their own items from a broad range of food and household products, which are provided for free by Cambridge City Foodbank. As well as affordable food, members can get expert advice from charities and professional agencies and get involved in events and opportunities in the community.

Financial donations are welcomed for either:

- A. The provision of free food and other free supplies to users of the Fairbite Food Club, which are additional to the items available for purchase by members, or to be used in activities such as Holiday Lunch Club which provide free food in the school holidays (this is consistent with the fundraising previously carried out by Queen Edith's Community Forum).
- B. The general running costs of the Fairbite Food Club (this contributes towards the cost of employing our coordinator and modest overheads). If the combination of grants, donations and membership fees paid by members for their shopping exceed the running costs, an amount (capped at the amount of membership fees) may be paid to Cambridge City Foodbank as a contribution towards the costs of their free provision of the core food and other supplies available to members.

As St James' Church is a regulated charity for UK tax purposes (registered with the Charity Commission, number 1212567), financial donations are eligible for Gift Aid relief for UK taxpayers. In the unlikely event of excessive donations that are not expected to be able to be used for the Fairbite Food Club Queen Edith's within a reasonable period, St James Church may donate funds to other charities for the relief of food poverty in the local area. For the avoidance of doubt, these funds may not be used for other purposes, e.g. for general church activities. Any Gift Aid tax refund received by St James Church in connection with these donations will also be subject to the same limitations on usage as the linked donation.

In compliance with the General Data Protection Regulations (GDPR), we will only use the data in this form in accordance with the permitted purposes, specifically to plan the finances of the Fairbite Food Club and maintain accounts and records (including the processing of gift aid applications).
